

**SUMMARY ANNUAL REPORT FOR
ST. PAUL ELECTRICAL CONSTRUCTION WORKERS SUPPLEMENTAL PENSION PLAN**

This is a summary of the annual report of the ST. PAUL ELECTRICAL CONSTRUCTION WORKERS SUPPLEMENTAL PENSION PLAN (Employer Identification Number 41-6046858 Plan 003) for the plan year October 1, 2020 through September 30, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$245,971,302 as of the end of the plan year, compared to \$205,862,781 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$40,108,521. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$53,411,342, including income from investments of \$43,513,736, employer contributions of \$9,892,863, and other income of \$4,743. Plan expenses were \$13,302,821. These expenses included \$12,368,358 in benefits paid and \$934,463 in administrative expenses. A total of 3,551 persons were participants in or beneficiaries of the plan at the end of the plan year.
